

RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility:** This Campaign is open only to those who register and attend the ASCRS Annual Meeting and who are 18 years of age or older as of the date of entry. The Campaign is void where prohibited by law. Employees of the American Society of Cataract & Refractive Surgery (ASCRS), Inc., its affiliates, vendors, exhibitors, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. - 4. How to Enter:** The Campaign must be entered by registering and attending the ASCRS Annual Meeting and clicking on designated pages/tiles to earn points. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that do not adhere to the rules or specifications may be disqualified at the sole discretion of ASCRS. Each valid Annual Virtual Meeting registrant may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.
